*Horseback handling allowed in all stakes except the Walking Stakes; no handler horses provided.

*Tracking collars permitted in accordance with AKC rules.

Bitches in season permitted to run in accordance with AKC rules and regulations.

FIREARMS

Shotguns will not be permitted on the grounds. Only a solid barrel firearm or plugged barrel firearm, with blank shells, which prevents a projectile of any kind from leaving the barrel permitted in any stake.

Rosettes to all placed dogs. Trophy to first place.
