### TRACKING COLLARS

The use of approved AKC Tracking Collars will be permitted. The hand held “locating” receiver shall be kept in the possession of the judge or designee.

The receiver may only be used after the dog is determined out of judgment and No longer eligible for placement.

**Exhibitors should follow their veterinarian recommendation to assure their dogs are free from external and internal parasites, any communicable diseases, and have appropriate vaccinations.**
