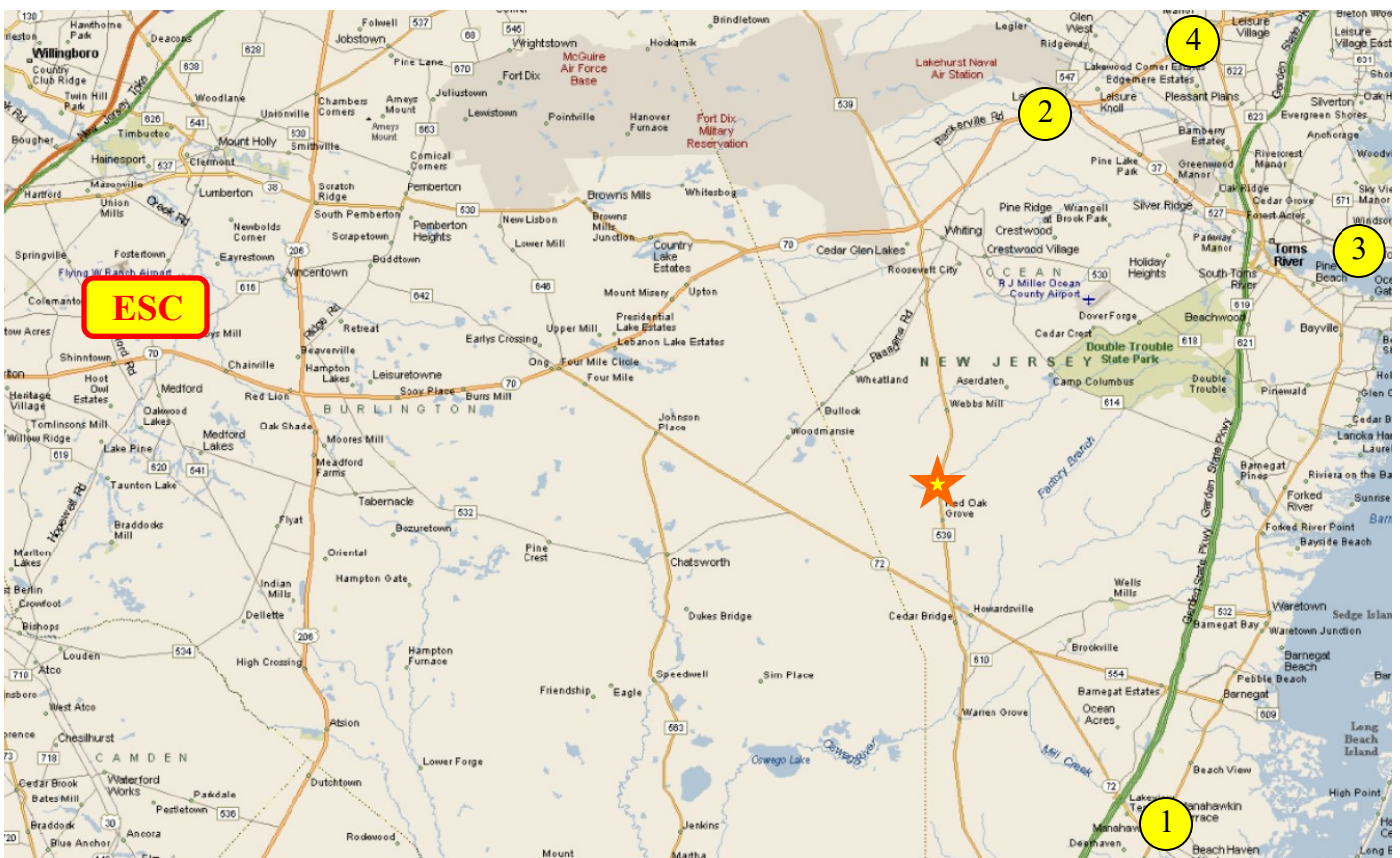
Anthracite will be running a walking field trial at the same time and location. This provides everyone the opportunity to walk their dogs or compete on horseback
