

DIRECTIONS TO GROUNDS

FROM THE INTERSECTION OF ROUTE 4, ROUTE 150
AND COUNTY LINE ROAD (between Cutler and Percy):

Travel south on Route 4 approximately 1 mile
Turn left on Pyatt -Cutler Road, Look for Pyramid Park Sign before
the turn. Travel approximately 5.5 miles east on Pyatt Cutler
Turn left at the entrance—**just opposite** the Denmark park
sign (on the right) Pass through the yellow gate, turning left when
you get to the barn road. Parking lot is on the right. **
