2 Miles South and 1 Mile West of Thayer, Iowa  
GPS coordinates: 40°59'55" N 94°03'39" W

From I-35 N or S

- Take exit 33 at Osceola
- Follow US Hwy 34 West approx 13 miles to Thayer
- Turn South on Hwy P-64 approx 2 miles to 210<sup>th</sup> St
- Turn West (right), go approx 1¼ mile, grounds on the right

From I-80 E or W

- Take exit 86 toward Greenfield/Creston
- Follow State Hwy 25 South to Creston
- Turn East on Hwy 34 approx 17 miles to Thayer
- Turn South on Hwy P-64 approx 2 miles to 210<sup>th</sup> St
- Turn West (right), go approx 1¼ mile, grounds on the right
