A blank cartridge will be fired in the Open and Amateur Puppy stake if bird contact occurs. Horseback handling is allowed in Open Limited, Open and Amateur All Age, Open Gun Dog, Open Puppy and Open Derby. AKC approved tracking collars are permitted for use, under AKC rules and regulations.

Spring 2018 Field Trial

The Michigan Brittany Club would like to welcome everyone to its Spring 2018 Field Trial. The trial will be held at the Ionia State Recreation Area, I-96 to Exit 67 (M66), North to David Hwy, West to Harwood, and North to Headquarters. Entries for the field trial will close on Monday, April 2, 2018 at the home of the Field Trial Secretary.

Placement in both Gun Dog Stakes will count toward the East Central Gun Dog of the Year Trophy.

This field trial will also be run as an American Field event. If your dog is registered with the American Field – Please include their FDSB registration number and color of the dog on the entry form.

All horses on the grounds need current coggins and health certificates. Handler horses are not supplied by the Michigan Brittany Club. If you would like to make your own arrangements to rent a horse contact Will Langley, Bottom Creek Farm, at (810) 338-8980 or Kathi at 810-338-0355.

Dogs need a current rabies vaccination certificate.

Saturday Evening - Please plan on joining us for a happy hour and dinner at the conclusion of the day's running.

State Park Permit- The Michigan DNR requires all vehicles on State grounds to display a Recreation Passport. These will be available for purchase at the grounds for \$11 (resident annual) or \$9/\$31 (daily/annual) for non-residents.

Parking /Camping- Camping is permitted on Headquarter grounds. Only campers desiring electricity should park in the area with electrical outlets. Camping fees (\$7 per day) are paid directly to the Michigan Brittany Club. Fees for an electrical hookup (\$5 per day) are also to be paid directly to the Michigan Brittany Club. There is no parking anywhere along the park service road or highway. Use designated parking lots only. Park perpendicular to posts in the Headquarters Parking Lot. There is no parking in the middle of the lot.
