**BITCHES IN SEASON** – Bitches in season will only be allowed to compete In the AGD

**STATE PARK PERMIT** – The Michigan DNR requires all vehicles on State grounds to display a Recreation Passport. These will be available for purchase at the grounds for \$19 (resident annual) or \$11/\$40 (daily/annual) for non-residents.

**PARKING/OVERNIGHT ATTENDANTS** – Overnight attendants are permitted on Headquarter grounds. Only overnight attendants desiring electricity should park in the area with electrical outlets. **Fees of \$20 per day with electrical hookup and \$15 per day without are paid directly to the club.**
