Horseback handling will be permitted in all stakes except the Amtr Walking Gun Dog Open Limited Gun Dog, Amtr Puppy and Amtr Derby Where Walking Handlers ONLY.

A blank cartridge **WILL NOT** be fired in the Puppy Stake.
