CORRALS, STALLS, KENNELS are available on the grounds. *Please clean before leaving. No dog training is allowed on the field trial grounds*, but adjacent areas for roading and running dogs is available on specified days. A NC Permit must be obtained.

CAMPING: Camping is permitted on the grounds. **ELECTRICAL HOOKUPS WILL BE AVAILABLE at \$10/day BUT NOT ALLOWED BEHIND THE BARN. NO PARKING NEXT TO CLUBHOUSE.**

DIRECTIONS: From Southern Pines: Take US 1 South past Pinebluff until the divided highway ends at the bottom of small hill and crosses Drowning Creek. From that point, go 4.6 miles. Turn right (BP Gas Station on near right side) in Hoffman on Caddel Rd. Go short distance (about .1) and turn right when the road splits with island. Continue approximately 3 miles to entrance to field trial area on left. Follow sand road approximately 3 miles to clubhouse. From 220 South, take exit 41 (old exit 24), turn left at end of ramp, go approx. 2/10 mi. and turn left on Windblow Rd., cross Rt. 73 and follow to end. Turn right and look for entrance to trial grounds on right.
