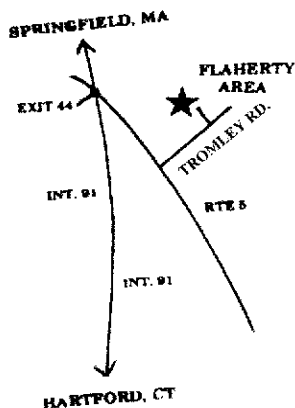
SOUTHERN NEW ENGLAND BRITTANY CLUB

The officers and members of the Southern New England Brittany Club invite you to join us at our spring field trial to be held at the John Flaherty Field Trial Area on Tromley Road in East Windsor, Connecticut on April 21-22 2018. This trial is sanctioned by both AKC and American Field.

Please note the following information:

- Camping is permitted but there are no hookups, water is available.
PLEASE NOTE: Per state regulations, camping is permitted 1 day prior to and 1 day after the trial.
- There will be a wrangler at this trial. Handlers are to make their own arrangements for horses.
- Food will be available at the clubhouse both Saturday and Sunday.
- The club requests that dogs not be left on stakeout chain unless someone is to be in the immediate vicinity. Please be sure that all horses are properly secured after the day's running.
- Happy hour and dinner will follow completion of the last brace on Saturday.



DIRECTIONS: The trial grounds are located in East Windsor, Connecticut on Tromley Road, just off Rte. 5.

From the north take Interstate 91 south from Springfield, Mass. Take exit 44. Follow Rte. 5 south approximately 1.5 miles. Take left on Tromley Road. Grounds are well marked.

From the south take Interstate 91 north from Hartford, CT. Take exit 44. Follow Rte. 5 south approximately 1.5 miles. Take left on Tromley Road. Grounds are well marked.
