I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. 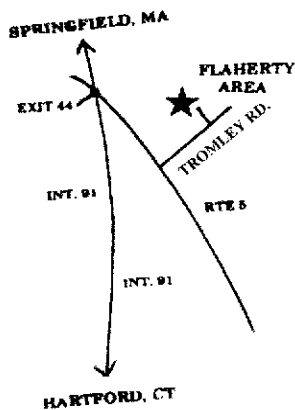

- **PLEASE NOTE:** *Per state regulations, camping is permitted 1 day prior to and 1 day after the trial.*  
 There will be a wrangler at this trial. Handlers are to make their own arrangements for horses.  
 The club requests that dogs not be left on stakeouts unless someone is in the immediate vicinity.  
 Be sure all horses are properly secured after the day's running..

- Lunches will be available daily. There will be a dinner on Tuesday for last year's winner and a dinner and awesome raffle on Saturday night.
- A donation of \$1 per dog will be made to The Bird Dog Hall of Fame from the trials' profits.

- SNEBC's trials are 2 entirely separate events. One is horseback and the other walking.
