CLOSING DATE & DRAWING: **SUNDAY, JANUARY 6, 2019-6PM** Drawing will be held at 6:00 PM by the Field Trial Secretary (at 2180 Hutcheson Rd, Baskerville, VA). **PLEASE NOTE**** ALL ENTRY FORMS MUST BE MAILED BEFORE BEING DRAWN AND ENTRY FEES PAID BEFORE ANY DOG IS PERMITTED TO RUN. ENTRIES POSTMARKED BEFORE DECEMBER 7, 2018, WILL NOT BE ACCEPTED.**

ALL ADULT AND JUVENILE STAKES will be run on the Hoffman Field Trial Grounds. Hunting license from your state required.

CORRALS, STALLS, KENNELS are available on the grounds. *Please clean before leaving.* No dog training is allowed on the field trial grounds, but adjacent areas for roading and running dogs is available on specified days. A NC Permit must be obtained.

CAMPING: Camping is permitted on the grounds Friday, Saturday, Sunday, Monday nights. **NO ELECTRICAL HOOKUPS WILL BE AVAILABLE OR ALLOWED BEHIND THE BARN. NO PARKING NEXT TO CLUBHOUSE.** Electric available on the far left of the barn for nominal charge.

HOSPITALITY HOUR: Friday night bring a dish to the clubhouse for potluck dinner. Saturday night Judges' Dinner in the clubhouse. Sunday night Tarheel Brittany Club hosts a Hospitality Hour followed by dinner in the clubhouse.

DIRECTIONS: From Southern Pines: Take US 1 South until it crosses new bridge crossing Drowning Creek at bottom of small hill (construction). From that point, go 4.6 miles. Turn right (BP Gas Station on near right side) on Caddell Rd. Go short distance (about .1) and turn right when the road splits with island. Continue approximately 3 miles to entrance to field trial area on left. Follow sand road approximately 3 miles to clubhouse. From 220 South, take exit 41 (old exit 24), turn left at end of ramp, go approx. 2/10 mi. and turn left on Windblow Rd., cross Rt. 73 and follow to end. Turn right and look for entrance to trial grounds on right.
