If it rains and the grounds are wet, please stay parked in the main gravel parking areas to avoid creating ruts and other damage to the fields.

Group meals are not scheduled at this time.

GROUNDS

Limitations include but are not limited to the following:

- Overnight camping on the grounds or parking lot is not permitted.
- Vehicles are confined to the designated parking area.
- Limited parking on the grounds is permitted for Judges and to facilitate event general conditions.

- Limited participant parking on the grounds "may" become available (weather conditions permitting), see FT personnel. Use Extreme caution when vehicles cross the Centennial Trail.
- A WDFW vehicle permit, or a Discover Pass is required to park on grounds or parking lot. Available at https://store.discoverpass.wa.gov/
- Only permitted vehicles allowed to drive on any course.
- Smoking on the grounds or outside of your vehicle is prohibited.
- No open fires.
- No potable drinking water is available.
- Read and abide by all posted rules and regulation at the WDFW Stillwater dog training wildlife area before and after the field trial.

Go past Carnation for approx. 3.7 miles to Fey Road on right. North parking lot is to the left.

From Everett WA:

Take US-2 East to Monroe. Take a right onto SR-203 / N Lewis St. Proceed through Duvall to the roundabout, take 2nd exit, onto WA-203 /Carnation-Duvall Rd NE. Proceed to Fey Road on left. Turn right into North parking lot.
