

Fall 2024 Field Trial

The Western Michigan Brittany Club would like to welcome everyone to its Fall 2024 Field Trial. The trial will be held at the Ionia State Recreation Area, I-96 to Exit 67 (M66), North to David Hwy, West to Harwood, and North to Headquarters. Entries for the field trial will close on Wednesday, August 28, 2024, at the home of the Field Trial Secretary.

Placement in both Gun Dog Stakes will count toward the East Central Gun Dog of the Year Trophy.

All horses on the grounds need current Coggins and health certificates. The Western Michigan Brittany Club does not supply horses for handlers. **There will not be a wrangler on the grounds to rent horses from.**

Dogs need a current rabies vaccination certificate.

Stable will be unavailable to stall horses.

Sunday Evening - The club invites all participants to join us for dinner at the conclusion of the day's running. The club will not be serving lunches. Coffee and breakfast treats will be available each morning as well as water in the clubhouse. This information is all based on current Covid 19 guidelines and mandates.

State Park Permit- The Michigan DNR requires all vehicles on State grounds to display a Recreation Passport. These will be available for purchase at the grounds for \$18 (resident annual) or \$11/\$39 (daily/annual) for non-residents.

Parking /Camping- Camping is permitted on Headquarter grounds. Only campers desiring electricity should park in the area with electrical outlets. Camping fees (\$15 per night without electricity, \$20 per night with electricity) are paid directly to the Western Michigan Brittany Club. There is no parking anywhere along the park service road or highway. Use designated parking lots only. Park perpendicular to posts in the Headquarters Parking Lot. There is no parking in the middle of the lot.

All stakes are a single course without a bird field. Native and/or released Quail are used in all stakes, except the Open Puppy stake. A blank cartridge will be fired in the Open Puppy stake if bird contact occurs. Horseback handling is only allowed in Open Limited All Age, Open Gun Dog, Open and Amateur All Age, Open Derby, and Open Puppy. AKC approved tracking collars are permitted for use, under AKC rules and regulations.
