The average Brittany can be developed into a field trial winner with proper training and experience, but correct type can only be bred into a dog. Past history has demonstrated that dogs which meet certain requirements in body construction turn in the most satisfactory performance in the field. Thus the standard of physical perfection. When selecting a stud remember the feeding cost and training are the same regardless of whether you have a good or poor specimen.
