TO ALL DIRECTORS AND OFFICERS

Enclosed are the 2008 annual financial statements. The year resulted in a very small deficit, which approximated the budgeted amount. We continue to be strong financially and have an adequate cash cushion to weather what appears to be a year of tough economic times with the resulting drop in recording fees, dues and other activities. Should this situation continue past 2009, the Board will need to consider what actions need to be taken.

Significant variances for 2008 compared to 2007 are:

- Magazine advertising income has decreased; however printing costs have also decreased in a similar amount, thus no impact on the bottom line.
- Magazine postage in 2007 was reduced by a credit balance that had accumulated in our postage account as a result of mailing fewer copies each month. That credit balance was used up in 2007.
- Our AKC delegate was unable to attend some of the meetings in late 2007 and early 2008; thus reducing those costs.
- In 2007, the national open and amateur championships had a large surplus, resulting from 2nd and 3rd place dogs in the open championship not being sold in the Calcutta with ABC retaining that portion of the purse as well as there was a larger number of entries in 2007. With the revision to amateur qualifications for the 2009 nationals, that will hopefully help to increase the number of entries in the amateur stake.
- The national open gun dog and amateur gun dog championships experienced a drop in entries in 2008, resulting in a deficit.
- The national specialty show also had a drop in entries, resulting in a deficit in 2008. In 2007, the show broke even.

Details of the 2008 all age and gun dog championships as well as the specialty show have been provided to the respective vice presidents. It is imperative that we take a close look at the income and expenses of each of these events and make the necessary adjustments to bring them to a breakeven status for 2009 and following years. The gun dog nationals and specialty show have historically (see 5-year comparison) struggled to generate enough income to cover their expenses.
