**DIRECTIONS:** From Southern Pines: Take US 1 South until it crosses the new bridge crossing Drowning Creek at bottom of small hill. From that point, go 4.6 miles. Turn right (BP Gas Station on near right side) on Caddell Rd. Go a short distance (about .1) and turn right when the road splits. Continue approximately 3 miles to the entrance to field trial area on left. Follow sand road approximately 3 miles to clubhouse. From 220 South, take exit 24, turn left at the end of the ramp, go approx. 2/10 mi. and turn left on Windblow Rd., cross Rt. 73 and follow to the end. Turn right and look for the entrance to the trial grounds on the right.
