ENTRIES POSTMARKED BEFORE DECEMBER 7, 2024, WILL NOT BE ACCEPTED.**

**ALL ADULT AND JUVENILE STAKES** will be run on the Hoffman Field Trial Grounds with exception of Open Puppy which may run off the grounds.

**CORRALS, STALLS, KENNELS** are available on the grounds. *Please clean before leaving.* No dog training is allowed on the field trial grounds, but adjacent areas for roading and running dogs is available on specified days. A NC or home Hunting License is required.

**CAMPING:** Camping is permitted on the grounds Friday, Saturday, Sunday, Monday and Tuesday nights. **NO ELECTRICAL HOOKUPS WILL BE AVAILABLE OR ALLOWED BEHIND THE BARN. NO PARKING NEXT TO CLUBHOUSE.** Electric available on the far left of the barn for \$10 a day. Please pay Field Trial Secretary!

**FOOD:** Coffee will be available in the morning and Lunch will be served in the Clubhouse Saturday thru Tuesday. Dinner will be served Sunday night in the clubhouse. **Cost \$5.00.**

**DIRECTIONS:** From Southern Pines: Take US 1 South until it crosses new bridge crossing Drowning Creek at bottom of small hill. From there, go 4.6 miles. Turn right (BP Gas Station is on right) onto Caddel Rd. Go short distance (about .1) and turn right when the road splits with island. Continue approximately 3 miles to entrance (marked by a wooden sign) for the field trial area on left. Turn left. Follow sand road approximately 3 miles to clubhouse. Bear slight left when you come to the 5-way intersection. Continue until you see clubhouse on right. From 220 South, take exit 41 (old exit 24), turn left at end of ramp, go approx. 2/10 mi. and turn left on Windblow Rd., cross Rt. 73 and follow to end. Turn right and look for entrance to trial grounds on right.
