Please remember: An event has final approval only when both the application and the judges panel have been approved. Your club will be sent notification of both.

When approved, the information given on this form must be printed in the Premium List along with any other information required under the repective Hunting Test Regulations. As stated in AKC's Regulations, clubs must submit Premium Lists to the AKC at the time of distribution. Premium List may be submitted by mail or email.
