

## Northern California Brittany Club (NCBC)

**ASSUMPTION OF RISK:** I am aware that sports, outdoor recreational activities, activities involving firearms, activities involving animals, social gatherings, and other programs, events and activities sponsored by or attended by NCBC can be hazardous, and participation therein carries inherent risks that cannot be eliminated regardless of the care taken to avoid illness or injuries to humans and/or pets. The specific risks vary from one activity to another, but the activities include the risk of injury which can range from: (1) minor injuries such as sprains, scratches and bruises; (2) more significant injuries such as injuries to eyes, muscles, joints, ligaments, the spine, heart attack, concussion, and deep cuts; to (3) paralysis, blindness, or death.

I voluntarily accept full responsibility for all risks involved in the events, programs, and activities in which I participate.

**ADHERENCE TO SAFETY PROTOCOLS:** I accept as my own responsibility to obey all posted behavior notices, Federal, State, County, and City protocols, and any other safety rules, policies, and directives given by NCBC staff and volunteers. It is my responsibility to conduct myself in a safe and appropriate manner for each event, program, and activity in which I participate. Any equipment I use while participating in any NCBC event, program, and activity, I use at my own risk and acknowledge I am familiar with and know how to properly and safely use such equipment after I have inspected the same.

**WAIVER:** In consideration of being permitted to participate in any way in the NCBC event, program, and activity, I agree to RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, NCBC, all instructors, and any of (their/its) employees, volunteers, judges, agents, contractors, subsidiaries, officers or owners from any and all claims for injury or damage resulting from any cause, including the negligence of NCBC, all instructors, and any of (their/its) employees, volunteers, judges, agents, contractors, subsidiaries, officers or owners resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in or travel to and from the NCBC event, program, and activity. I agree not to sue any of the aforementioned on the basis of these waived and released claims. This waiver extends to all claims, known or unknown to me at the time I signed this document. I understand that NCBC would not permit me to participate in the NCBC event, program, or activity without my agreeing to these waivers. This covenant binds myself, as well as my heirs, personal representatives, and assigns.

**INDEMNITY:** I agree to INDEMNIFY AND HOLD NCBC and any of its employees, volunteers, agents, contractors, subsidiaries, officers or owners HARMLESS, from all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in any NCBC event, program, or activity, and to reimburse all of them for any such expenses they may have incurred as a result thereof.
